Duplications are limited. Acceptance is on a first come first served basis. This contract will be **STRICTLY ENFORCED**. Please take this into consideration when completing this application.

- Ø The fee for your concession is to be paid to the Wasco Festival of Roses, Inc. at the time your contract is submitted.
- Ø **Artisan fee:** \$100.00
Concessionaire fee: \$100.00 for single item, \$150.00 for plate meal
- Ø If application is declined, your check will be returned to you.
All vendors must submit a current seller's permit number.
The Outdoor Art Faire hours are: Saturday 10:00a.m. - 6:00p.m.
- Ø **SATURDAY ONLY EVENT**
- Ø ***If you need more than 12 X 12 space for a vehicle or exhibit, you must make prior arrangements with the Festival Committee. This is strictly enforced.***
- Ø **DO NOT** assume that we know your needs. The committee will need **all** of your information. Extra space will be available for an additional fee. Bring your own shade, tables, easels, generators, etc. **AS THESE ITEMS WILL NOT BE PROVIDED.**
- Ø There will be security on duty Friday from 11:00 p.m. - 6:00 a.m.
- Ø Early arrivals will not be permitted to set up until after 5:00 p.m. on Friday
- Ø Please do not abuse the privilege by entering the grounds before the Festival Committee is set up.
- Ø A committee member will be in the park to answer your questions on Friday from 5:00 - 7:00p.m. and Saturday at 6:30a.m.
- Ø ***All Artisans must submit photos and descriptions of their work, including price range. NO EXCEPTIONS! Even past exhibitors.***
- Ø Food Concessionaries must provide insurance and health permit documents within 10 days of acceptance by the Festival Committee.
- Ø Upon arrival to Barker Park, please check in at the information booth to pick up your Vendor badge and Booth location.

Artisans & Concession Agreement

PURPOSE:

In order for all parties involved to have specific guidelines, and in order for Wasco Festival of Roses, Inc. to have a record of the following agreement, the following terms are agreed to by the Wasco Festival of Roses, Inc. and _____

TERMS:

1. The Artisan/Concessionaire hereinafter called "APPLICANT" agrees to operate a booth at the Wasco Festival of Roses Art Fair in Barker Park
2. Please indicate any special needs you may have. We will do our best to accommodate your request. Special needs:
3. The non-refundable fee will be paid to the Wasco Festival of Roses, Inc. by the applicant at the time this signed agreement is submitted. The fee will be deposited upon acceptance of agreement.
4. I/We the applicant(s) agree to sell only the following items listed below:

5. I/We the applicant(s) understand that the Wasco Festival of Roses Inc. assumes no responsibility for the safety of my display during or after Festival hours.
6. I/We the applicant(s) understand that the Wasco Festival of Roses Inc. agrees to provide a 12 X 12 area for my booth.
7. I/We the applicant(s) understand the electricity and shade for my booth are my responsibility.
8. I/We the applicant(s) understand that the electricity will not be provided at anytime, day or night, by the Festival.
9. I/We the applicant(s) understand that due to restrictions made by the property owner, I/We will no longer be allowed to sell the following items: Any type of gum, silly string, color spray cans, confetti poppers, invisible ink or any other type of item the Festival Committee deems destructive or that contributes to excessive litter.

PENALTIES FOR NON-COMPLIANCE TO AGREEMENT

The applicant agrees to the following for non-compliance to this agreement:

1. In the event the applicant sells unauthorized items (items not listed on page 2), a penalty in the amount equal to the initial concession fee shall be paid to the Wasco Festival of Roses, Inc., by the applicant and will be asked to immediately refrain from selling the unauthorized items.
2. If the applicant refuses to pay the penalty or continues to sell the unauthorized items, the Rose Festival security will shut down the concession and applicant will not be allowed to operate in future festivals.

AGREEMENT:

I/We the undersigned agree to all terms set forth in this contract and will abide by all terms of this contract. I/We further agree to the penalties set forth in this contract and agree, in the event enactment of these penalties become necessary against me/us by the stated penalties. I/We also acknowledge that I/We have kept a copy of this contract and understand all items set forth in it.
